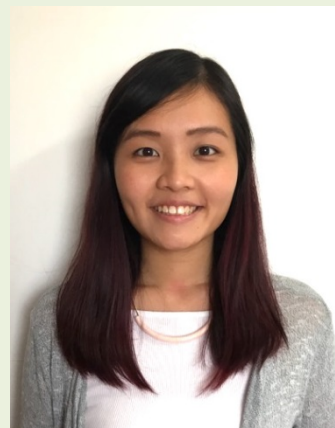

Ms. Kamila Slavíková

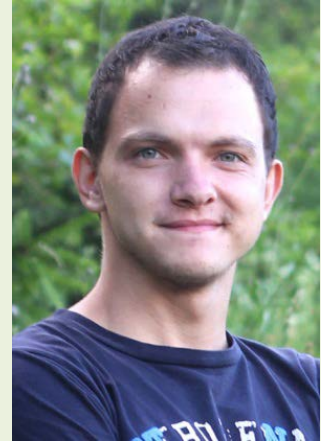

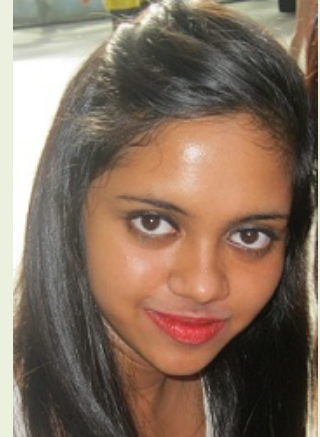
