Dr Ralf Emmers is Associate Professor and Coordinator of the Multilateralism and Regionalism Programme at the S. Rajaratnam School of International Studies (RSIS), Nanyang Technological University (NTU), Singapore. He completed his MSc and PhD in the International Relations Department of the London School of Economics (LSE). His research interests cover security studies and international relations theory, maritime security, international institutions in the Asia-Pacific, and the security and international politics of Southeast Asia. Dr Emmers is the co- Series Editor of the Warwick Studies in Globalisation (Routledge Book Series) and an Editorial Board member of The Pacific Review.

Dr Emmers' professional activities have included serving as the Acting Head of the Centre for Non-Traditional Security Studies (2011) and as the Head of Graduate Studies (2006-2009) at RSIS; as a Visiting Fellow at the Australian National University/Griffith University (2009), funded by the Australian Research Council (ARC) Center of Excellence in Policing and Security (CEPS); as a Participant at the CSCAP Study Group on Human Trafficking in the Asia-Pacific Region (2005); as a Ford Fellow on Non-Traditional Security in Asia (2003-05), Institute of Defence and Strategic Studies (IDSS); as an IDSS Post Doctoral Fellow in Asian Security (2002); and as a Research Associate at the Institute of Southeast Asian Studies (ISEAS), Singapore, and the Center for Strategic and International Studies (CSIS), Jakarta (2000).

Dr Emmers is the author or editor of 11 books and monographs and has contributed numerous journal articles and book chapters in edited volumes. He is the author of Resource Management and Contested Territories in East Asia (Palgrave Macmillan, 2013), Geopolitics and Maritime Territorial Disputes in East Asia (Routledge, 2010), Cooperative Security and the Balance of Power in ASEAN and the ARF (RoutledgeCurzon, 2003) and Non-Traditional Security in the Asia-Pacific: The Dynamics of Securitization (Marshall Cavendish, 2004) and the co-author of The East Asia Summit and the Regional Security Architecture (University of Maryland School of Law, 2011). He is the editor of ASEAN and the Institutionalization of East Asia (Routledge, 2012) and the co-editor of The Five Power Defence Arrangements at Forty (Institute of Southeast Asian Studies,

2011), Security and International Politics in the South China Sea: Towards a Co-operative Management Regime (Routledge, 2009), Order and Security in Southeast Asia: Essays in Memory of Michael Leifer (Routledge, 2006), Understanding Non-Traditional Security in Asia: Dilemmas in Securitization (Ashgate, 2006), and of Non-Traditional Security in Asia: Trends and Issues (Marshall Cavendish, 2006). Additionally, he has published articles in peer-reviewed journals such as The Pacific Review, Asian Survey, Australian Journal of International Affairs, Asian Security, Harvard Asia Quarterly, Contemporary Southeast Asia, Contemporary Politics, Political Science, Pointer and Dialogue + Cooperation as well as numerous book chapters in edited volumes. He is one of the authors of a monograph on A New Agenda for the ASEAN Regional Forum (IDSS, 2002) and of An Agenda for the East Asia Summit (IDSS, 2005) as well as a contributor to International Relations in Southeast Asia: The Struggle for Autonomy (Rowman & Littlefield, 2005).

Dr Emmers teaches a course on the Study of International Institutions as part of the MSc in International Relations at RSIS and lectures at the SAFTI Military Institute and the Home Team Command and Staff Course, Singapore.

James T.H. Tang, PhD
Dean and Professor of Political Science
School of Social Sciences, Singapore Management University

Professor James T.H. Tang is Dean and Professor of Political Science, School of Social Sciences, Singapore Management University (SMU). He is a specialist in international relations with special reference to China/Hong Kong and the Asia-Pacific region. Prior to joining SMU he was Professor in the Department of Politics and Public Administration at the University of Hong Kong (HKU).

A graduate of HKU, he obtained his M.Phil in International Relations at Cambridge University, and Ph.D. from the London School of Economics and Political Science.

Professor Tang began his academic career at the National University of Singapore in 1988 where he had his first full-time academic appointment. He joined HKU in 1991 and served as Head of the Department of Politics and Public Administration (1999-2002), Dean of Social Sciences (2002-2006), and founding director of the Master of International and Public Affairs programme. Professor Tang also held visiting appointments at leading universities in China, the UK, and the US and was a Visiting Fellow at the Brookings Institution in Washington D.C. (2005-06). Professor Tang has published extensively in his field and serves on the editorial boards of a number of academic journals including Asian Politics and Policy, Journal of East Asian Studies, Pacific Review, Political Science and International Affairs of the Asia-Pacific. He is currently working on a project about the implications of the rise of China for international relations theory and regional governance in East Asia.

Ambassador Karsten WARNECKE is the 7th Executive Director of the Asia-Europe Foundation (ASEF) in charge of the management and administration of the organisation, the implementation of its programmes and policies, and representing the organisation. He joined ASEF as the 6th Deputy Executive Director in August 2012.

Before joining ASEF, Ambassador WARNECKE dealt mainly with Germany's and the EU's involvement in ASEAN and in the ASEM Process as part of his portfolio as Counselor at the German Federal Foreign Office in Berlin, where he served as Deputy Head of Division for Regional Organizations and Cooperation in Asia-Pacific.

A seasoned career diplomat with over 25 years of experience, including almost 20 years with Asia, Ambassador WARNECKE is adept at working in cross-cultural settings and in bringing people together from diverse backgrounds. Chris Humphrey is the executive director of Singapore-based EU-ASEAN Business Council, a key business association that advocates for the interests of EU businesses operating in ASEAN. It is formally recognised as such by the European Commission and the ASEAN Secretariat.

Chris began his varied professional career as a UK civil servant where, amongst other things, he was Assistant Private Secretary to a Minister and an Air Services Trade Negotiator covering the Asia Pacific region. After leaving the civil service, Chris moved to the private sector working initially in the government and external relations teams at two British airlines in the UK, before moving to Shanghai, China with Virgin Atlantic where he headed up the airline's China operation and oversaw the rapid expansion of their business in China. Whilst in Shanghai, Chris also sat on the Executive Committee of the British Chamber of Commerce. He was also a Strauss Fellow at NYU and a Senior Fellow on the British ESRC 'UK in a Changing Europe' programme. He was co-editor of the European Law Review for six years and won the Wedderburn Prize in 1997 for best article in the Modern Law Review in that year.
